

**TOWN OF GOOD HOPE
COUNCIL MEETING MINUTES
JUNE 14, 2010**

OPEN: The council meeting was called to order by Pro Temp councilman, John Harris at the Good Hope Town Hall. Invocation was given by Danny Buchanan.

ROLL CALL: All council members were present. Mayor Corey Harbison entered the council meeting at 6:15 p.m.

MINUTES: Danny made the motion to approve and adopt May 10, 2010 council minutes. Maxie seconded the motion. Roll call vote: unanimous yea votes by the mayor and council.

REPORTS OF COUNCIL

PLACE ONE – JOHN HARRIS: John asked the council to review the bank balances of each account and the monthly financial report for May 2010. After review by the council, John made the motion to approve the financial statement. Maxie seconded the motion. Roll call vote: unanimous yea votes by the mayor and council.

PLACE TWO – MAXIE JONES: Maxie stated we need some bids for Schwaiger and Moehring Roads.

PLACE THREE – SUSAN ELLER: Susan commended that the sewer plant is in good shape at this time.

PLACE FOUR – JERRY BARTLETT: Jerry discussed the upcoming Good Hope Festival which will be held July 24, 2010 at Good Hope School on the old ball fields close to the bus barn. We are asking businesses to give donations to help pay for the rides for the children. We are not trying to make money, just help toward the expenses of the festival. Businesses who donate at least \$100.00, we will put out a sign for their advertisement. We are going to charge \$2.00 at the gate, but all children's games are free.

PLACE FIVE – DANNY BUCHANAN: Danny stated the ball season is over for this year. Everything went well this season. The district tournaments are starting.

RESOLUTIONS, ORDINANCES, ORDERS AND OTHER BUSINESS

STORM SHELTERS: Corey stated he had checked on getting a storm shelter for Good Hope. The cost is \$100,000.00 funded by federal grant. Corey asked the council to think about this project.

2010 REFUNDING WARRANT FOR WWTP: Council discussed refinancing the sewer 2001 refunding warrant, which would lower the interest on the bond. Susan made the motion to enter

an agreement with Walter Lewis of Gardnyr Michael Capital, Inc. for refinancing only the amount owed on the sewer bond at this time. Jerry seconded the motion. Roll call vote: unanimous yea votes by the mayor and council.

SCHWAIGER AND MOEHRING ROADS: Corey stated we can borrow money at approximately 4% interest for Schwaiger and Moehring roads. We will have bids at the next council meeting.

CLOSE: John made the motion to close the council meeting. Jerry seconded the motion. The council meeting was closed at 6:25 p.m. with the consent of the mayor and council.
