

**TOWN OF GOOD HOPE
COUNCIL MEETING MINUTES
NOVEMBER 08, 2010**

OPEN: The council meeting was called to order at 6:00 p.m. by Mayor Corey Harbison at the Good Hope Town Hall. Invocation was given by Danny Buchanan.

ROLL CALL: Mayor Corey Harbison and all council members were present with the exception of John Harris who was absent.

VISISTORS: Max Butram, and the newly elected district 12 Representative, thank everyone for their votes.

MINUTES: Motion: Danny Buchanan. Motion seconded: Maxie Jones. Roll call vote: unanimous yea votes by the mayor and council.

REPORTS OF COUNCIL

PLACE ONE - JOHN HARRIS: Corey ask the council to review the bank balances of each account and the monthly financial report for October 2010. After review and discussion Susan made the motion to accept and adopt the October financial report. Maxie second the motion. Roll call vote: unanimous yea votes by the mayor and council.

PLACE TWO- MAXIE JONES: We got the bids for paving the Deer Run Subdivision roads. Corey gave the bid prices from three separate companies. Good Hope Contracting gave the lowest bid. After discussion by the council Susan made the motion to except the bid from Good Hope Contracting Company. Maxie second the motion. Roll call vote: unanimous yea votes by the mayor and all the council.

PLACE THREE - SUSAN ELLER: We got a \$18,000 grant for the sewer upgrade. She ask Grady Parson from the Southwest Water Company to give a update on the sewer plant. Grady stated for October they had a good water control and discussed the system for the use of chlorine. Discussion was made to go ahead with the surveys so we can apply for the grant to extend sewer lines on Lindsey Road, Buettner Drive, Scott Drive and Schaeffel Road. Susan made the motion to go forward with the surveys. Danny second the motion. Roll call vote: unanimous yea votes by the mayor and all the council.

PLACE FOUR - JERRY BARLETT: Jerry discussed the Pre - Thanksgiving meal to be serve at the Good Hope High School lunch room . Jerry stated for this to be a success we need to feed 500 people.

PLACE FIVE - DANNY BUCHANAN: Danny commented that they was going to put up the Christmas tree in front of Town Hall if anyone wants to help or donate ornaments feel free to do so. Danny also stated that he would like playground equipment to be put at the municipal park as well as the family park.

RESOLUTION, ORDINANCES, ORDERS AND OTHER BUSINESS

OTHER BUSINESS: Corey commented on the youth football using our municipal park. Corey stated the council had voted in the past for them to use our fields but the motion was not intended to be permanently. Other parks charge a fee for the use of their parks maybe we should charge a fee to help toward the electric bill and maintenance of the park. After discussion by the council Susan made the motion to continue to allow the youth football to use the municipal park. The motion was second by Danny. Roll call vote: Corey, nay, Maxie, nay, Susan, yea, Jerry, yea, Danny, yea.

PLAYGROUND EQUIPMENT: Corey stated we have budgeted \$50,000 from the general fund for playground equipment. After discussion by the council Corey made the motion to put out bids for a larger playground set for the family park and a smaller set for the municipal park. Susan second the motion. Roll call vote: unanimous yea votes by the council.
