

**TOWN OF GOOD HOPE
COUNCIL MEETING MINUTES
JUNE 13, 2011**

OPEN: The council meeting was called to order by Mayor Corey Harbison at 6:00 P.M at the Good Hope Town Hall. Invocation was given by Danny Buchanan.

ROLL CALL: Mayor Corey Harbison, council members: John Harris, Maxie Jones, Susan Eller, and Jerry Bartlett were all present.

VISITORS: Billy Randall, Harold Russell, Carl and Fred all that which live on Megan Lane stated that the cars drive too fast down this road and do not obey the speed limit sign. Harold Russell stated that it is like a race track down Megan Lane. Carl also stated that big trucks come through there and have no place to turn around. They are hitting mail boxes when trying to turn around. They are here to ask the council to put up a 3 way stop sign at the intersection of Megan Lane and Midfield Drive. They also stated that the speed limit needs to be enforced. Jerry Bartlett stated that he does not believe that putting up a 3 way stop will slow the traffic down. Jerry also stated that the council would be willing to place the 3 way stop signs at Megan Lane and Midfield Drive to see if this would slow the traffic down.

PLACE THREE: SUSAN ELLER: Susan stated that the disinfection system is operational. Susan also stated that we need to provide a small chemical pump to transfer chlorine from the storage drums to the dosage drum.

PLACE FOUR: JERRY BARTLETT: Susan made the motion to allow Corey to send a letter of intent for community storm shelters. Seconded by John Harris. Roll call vote: unanimous yea votes by the mayor and council.

PLACE FOUR: DANNY BUCHANAN: Danny stated that the parks had a great turn out for the tournaments and that ball season is coming to an end.

John made the motion that the Town of Good Hope purchases the new business license program. Seconded by Maxie Jones. Roll call vote: unanimous yea votes by the mayor and council.
