

**CITY OF GOOD HOPE
COUNCIL MEETING MINUTES
AUGUST 8, 2011**

OPEN: The council meeting was called to order by Mayor Corey Harbison at 6:30 P.M at the Good Hope City Hall. Invocation was given by Maxie Jones.

ROLL CALL: Mayor Corey Harbison, council members: John Harris, Maxie Jones, Susan Eller, and Jerry Bartlett were all present.

MINUTES: Susan Eller made the motion to approve and adopt the June 25, 2011 council meeting minutes. The motion was seconded by Danny Buchanan. Roll call vote: unanimous yea votes by the mayor and council.

REPORT OF COUNCIL
