COUNCIL MEETING MINUTES  
APRIL 9, 2012**

**OPEN:** The Council meeting was called to order by Mayor Corey Harbison at 6:30 P.M at the Good Hope City Hall. Invocation was given by Maxie Jones.

Roll call vote: unanimous yea votes by the Mayor and Council.

**PLACE FIVE: DANNY BUCHANAN:** Danny stated that the ball season has started Danny thanks the Council for all the work that has been put into the parks.
