APRIL 23, 2012**

**OPEN:** The Council meeting was called to order by Mayor Corey Harbison at 6:30 P.M at the Good Hope City Hall. Invocation was given by Danny Buchanan.

**REPORT OF COUNCIL**

**LODGING TAX**

**RENTAL TAX**

John Harris made a motion to suspend the rules to be able to vote on an ordinance passing a 5 percent rental tax in the City of Good Hope. Danny seconded the motion. Roll call vote: unanimous yea votes by the Mayor and Council.

Jerry made a motion to adopt Ordinance 004-2012 stating the 5 percent rental tax in the City of Good Hope seconded by Maxie Jones. Roll call: unanimous yea votes by the Mayor and Council.

**OTHER BUSINESS**

**PUBLIC HEARING**

Corey addressed the council on applying for a Single Purpose Grant. Corey stated that the Grant will be used for sewer line extension for Lindsey Road and Buettner Drive. Corey also stated that the last Grant we applied for was a low pressure sewer line Grant. Corey stated that this Grant is for a Gravity System and feels like we have a better chance in receiving this Grant. The deadline for the Grant is May 15, 2012.

After discussion Susan made a motion to adopt a Resolution to apply for the Single Purpose Grant. The motion was seconded by Danny Buchanan. Roll call vote: unanimous yea votes by the Mayor and Council.

**CLOSE:** Susan made a motion to close the council meeting seconded by Jerry Bartlett. The council meeting was closed with the consent of the Mayor and the Council.
