

**CITY OF GOOD HOPE
COUNCIL MEETING MINUTES
OCTOBER 22, 2012**

PUBLIC HEARING

The Good Hope City Council conducted a public hearing at 6:30 P.M at the Good Hope City Hall regarding the alcohol applications for the following businesses: Good Hope Exxon, Jacks Truck Stop, and Jet Pep Food Mart.

Good Hope Exxon- John Harris made a motion to accept the alcohol application for RETAIL BEER (OFF PREMISES ONLY) from Good Hope Exxon located on 1734 County Road 437. The motion was seconded by Jerry Bartlett. Roll call vote: unanimous yeah votes by the Mayor and Council.

Jet Pep Food Mart- John made a motion to accept the alcohol application for RETAIL BEER and TABLE WINE (OFF PREMISES ONLY) from Jet Pep Food Mart located on 1690 County Road 437. The motion was seconded by Susan Eller. Roll call vote: unanimous yeah votes by the Mayor and Council.

Jacks Truck Stop- Jerry Bartlett made a motion to accept the alcohol application for RETAIL BEER and TABLE WINE (OFF PREMISES ONLY) from Jacks Truck Stop located on 1639 County Road 437. The motion was seconded by John Harris. Roll call vote: unanimous yeah votes by the Mayor and Council.
