COUNCIL MEETING MINUTES  
November 25, 2013 @ 6:30 pm**

**OPEN:** The Council meeting was called to order by Mayor Corey Harbison at 6:30 P.M. at the Good Hope City Hall. Invocation was given by Mayor Corey Harbison.

**ROLL CALL:** Mayor Corey Harbison, Council members: John Harris, Maxie Jones, Susan Eller, Jerry Bartlett and Matthew Glover were present.

**MINUTES:** John made a motion to approve and adopt the October 28, 2013 Council meeting minutes. The motion was seconded by Jerry. Roll call: unanimous yea votes by the Mayor and Council. **MOTION APPROVED**

**FINANCIALS:** John made a motion to approve and adopt the October 2013 Financial Statement. The motion was seconded by Jerry. Roll call: unanimous yea votes by the Mayor and Council. **MOTION APPROVED**

**PLACE ONE: JOHN HARRIS:** John presented the council with the current bank balances, list of all checks written through November 25, 2013.

**PLACE TWO: MAXIE JONES:** Maxie reported that street department had winterized Moehring Rd, Austin Dr, and Teem Rd with gravel.

**PLACE THREE: SUSAN ELLER:** Susan reported wastewater flows averages for October were 86,900 gallons a day and November is averaging 94,000 gallons per day. Living Water Services, LLC had requested some renovations at the wastewater treatment plant office at their expense.
