OPEN: The Council meeting was called to order Mayor Corey Harbison at 6:30 P.M. at the Good Hope City Hall. Invocation was given by John Harris.

Susan Eller made a motion to approve and adopt the 2014-2015 budget. The motion was seconded by John Harris. Roll call: unanimous yea votes by the Mayor and Council. **MOTION APPROVED**


