COUNCIL MEETING MINUTES
July 27, 2015**

OPEN: The Council meeting was called to order by Mayor Jerry Bartlett at 6:30 P.M. at the Good Hope City Hall. Invocation was given by Maxie Jones.

ROLL CALL: Mayor: Jerry Bartlett, Council members: John Harris, Maxie Jones, Susan Eller, Taft Dillashaw and Matthew Glover were present.

Susan Eller made a motion to give the seed money for the Athletic Training Facility Phase I at Good Hope High School in the amount of \$32,244.00 out of Alcohol Funds, based upon CCBOE approval of plans.
